RULES / REQUIREMENTS

1. Each team must have a team name creativity is encouraged.
2. There will be a woman's and a men's class.
 1. Three (3) individuals per team
 2. Two age divisions:
 1. 18 years and younger
 2. 18 years and older
3. Teams will start and stop at the sound of the whistle.
4. Each team member must have one (1) hand on the fence before the sound of the whistle.
5. Each team has 60 seconds to put the pig on top of the barrel.
6. Contestants can only use their arms and hands for catching. The pigs' ears, snout & tail are off limits.
7. All team members must be touching pig on the barrel for time to stop.
8. ABSOLUTELY NO roughing of the pig will be tolerated. Time will be stopped if the judge feels the pig is in trouble.
9. Pigs will be provided and only used once. One pig per team.
10. All team members must be present for a meeting at 3:30 p.m., which will be held in front of the Grandstand, or forfeit.
11. Judge's decision is FINAL!
12. NO REFUNDS.
